Statement of Educational Effectiveness

The ATS Educational Standard.6.4.4 requires us to make an annual public statement of our educational effectiveness.

Placement after graduation

The 2019 graduating class included 17 students. An important part of a school's effectiveness is following students after their graduation to see if receiving a degree made a difference in whether they were achieving their placement goals, especially since MDiv and MASC degrees are intended to help prepare students meet their vocational goals. ATS requires us to report these figures annually directly to our ATS accrediting body. The ATS categories are as follows:

Vocational placement: 11/17

This includes chaplaincy residency programs, paid internships, community ministry, etc.

Non-vocational placement: 2/17

This includes employment not directly related to the students' degrees

Further study: 2/17

Generally this includes doctoral programs, and in 2019 included a graduate who went on to rabbinical school.

Unknown: 2/17

We were not in contact with two students, and because we did not tabulate this statement of effectiveness until November 2019, we do not know where their paths took them after graduations in May.

Unitarian Universalist Ministerial Fellowship Committee

We are a Unitarian Universalist seminary, and UU students preparing for UU ministry want to know how successful our graduates are in passing the Ministerial Fellowship Committee (MFC) ordination interview. The MFC reports results to us (we are not given students' names). The report is by calendar year. We have 2018's numbers. Of 8 SKSM graduates who saw the MFC in 2018, seven of them passed immediately. The eighth student was told that they needed to fill in an academic gap and reappear before the Committee. They completed the requirement, went back to the MFC in 2019, and is now serving a congregation as the called minister.

In the 2019 class, there were:

- 6 Unitarian Universalists
- 13 MDiv students; 4 MASC students
- (all identified as men or women): 10 men and 7 women
- (with some missing data): 15 white and 2 people of color

In the 2019 class:

- 7 students had completed their degrees in 2-3 years
- 7 students had completed their degrees in 4-5 years
- 3 students had completed their degrees in 6 or more years

Annual Satisfaction Survey of Graduating Students

Every year we ask our graduating class to reflect on their satisfaction with the SKSM experience. We reached 12 of the 13 MDiv graduates. This is their response to our questions.
